Registration & Payment -

A registration fee of \$25 per student/family is due at the time of enrollment. This fee covers the cost of insurance, bookkeeping, costume measurements etc.

- -ALL PAYMENTS ARE NON-REFUNDABLE AND NON_TRANSFERABLE
- -Tuition payments are due on the 1st of each month. A late fee of \$25 will be assessed for payments made after the 7th. Students will not be allowed in class if tuition and late fees are not paid in full by the 15th of each month. Dancer's account must remain current in order to participate and be registered for performances, competitions, workshops, solos, etc.
- -Full tuition is charged monthly regardless of whether there are 3,4 or 5 weeks in that month. Holidays, shortened months, recitals and school/studio breaks have been considered and are reflected in the monthly tuition cost.
- -There are no refunds or deductions for classes missed, makeup classes may only be available if we cancel due to weather. Tuition will not be adjusted or pro-rated for missed classes due to illness or vacations.
- -Monthly tuition is paid by WAVE which is invoiced through your email you register with.
- -A \$25 fee is charged for any returned check. After 2 returned checks; only payments of cash will be accepted. Post-dated checks will not be accepted.

Studio Policies-

- -Once registered in a class, the student is enrolled indefinitely until you, as a parent or guardian, choose to fill out a withdrawal form and withdraw the student. Withdrawal forms must be filled out or written notice given, 7 days prior to the 1st of the month; in order not to be charged for the next month's tuition.
- -Class changes must be made 7 days prior to the 1st of the month in order to not be charged for the next month.
- -NEW POLICY both Withdraws & Class Change's (only drop) will require a \$25.00 fee.
- -Students should NOT be dropped at the studio earlier than 10 minutes before their class or picked up later than 10 minutes after their class. For safety reasons; students are not allowed to wait outside the studio. They must wait inside for their ride.
- -Class Times may vary, some classes may run up to 10 minutes over their class time for instructors to finish all curriculum. Please plan for this accordingly.
- -The Dance Factory is not responsible for items left at the studio. Please make sure your dancer keeps their belongings in a dance bag that zips.
- -I, hereby release The Dance Factory and all staff members from all claims of damages or injury suffered by the above registered student, in connection with or by their association with The Dance Factory. This includes my heirs, who may not act on behalf. (Note: Each student should be covered under some kind of individual insurance policy. The Dance Factory will not be held responsible.)

Payment Information-

-All of our payments are done through invoicing online through our new system "Wave Payments". You will receive an email monthly for your tuition payment. You are also able to sign up for auto pay on your monthly tuition for it to come out on the first of the month every month until the session is over or canceled. You will need a Credit/Debit Card or Bank Account to enter. Auto Pay is just for Tuition payments, this does not include extra fees (costume fees, registration fees, competition fees etc.) those fees will be invoiced separately. You can modify your card information at any time.

If you do not want to do auto pay, you will be invoiced monthly through your email to make your payments.

-You will receive your first invoice the week classes begin. Please refer to the pricing list on our website for exact payment amounts if you have any questions. All recreational dancers will pay monthly tuition and additional fees include a one time \$25 registration fee. Registration fee may be discounted if attending open house. Competition dancers can expect separate fees discussed at the parent meeting. Recreational classes will consist of a \$55 costume per class. This excludes conditioning and team technique training classes, company barre (Acro & Tumble will be the same costume so no extra fee if taking both).

Checks will still be accepted but **NO LONGER MAILED**. Checks must be brought to the Studio Office if wishing to pay by check.
